About the role

Bridges After Hours GP Clinic in Kanwal, is a CCPC health program, which provides after hours GP care to the public. Our service is a walk-in service with no appointment necessary.

You will be required to undertake a range of tasks including but not limited to the following:

- provide medical advice and assistance to patients (including via telephone where necessary) or, where unable to provide adequate or appropriate assistance, arrange for their transfer to another service provider.
- undertake home visits where required after the rostered shift.
- fulfill clinical responsibilities in accordance with accepted medical practice, and in a manner which is respectful of the relationship between the patient and their regular GP.
- comply with all relevant legislation, including but not limited to the <u>Privacy Act 1988</u> (<u>Cth</u>), the <u>Privacy and Personal Information Act 1998 (NSW)</u>, the <u>Child Protection Act</u> (<u>Working With Children</u>) <u>Act 2012 (NSW</u>) and the <u>Medical Practice Regulation 1998</u> (NSW).
- complete medical and service records for all patients in a timely manner (i.e. on the day of the shift).
- report the details of any episode or incident that could impact adversely on your reputation or the reputation of CCPC or a related entity.

You will be required to work during the following span of hours:

- 7:00pm 10:30pm, Monday Friday
- 3:00pm 10:30pm, Saturday
- 1:00pm 6.00pm, Sunday and Public Holiday
